Altvest provides for the investment into, and secondary market trading of, individual institutional grade alternative investments, thereby democratising access to previously inaccessible investment opportunities that have traditionally offered noncorrelated excess returns vs traditional equity investments. Altvest transforms the private equity landscape by allowing direct retail and institutional participation in listed instruments representing an economic interest in individual private equity assets. The objectives of the fund are two-fold.

1. To provide retail and institutional investors with access to alternative assets to in a cost effective, regulated environment.
2. To create alternative avenues for entrepreneurs to raise capital, through impact investing with the ultimate aim of growing the South African economy and creating jobs

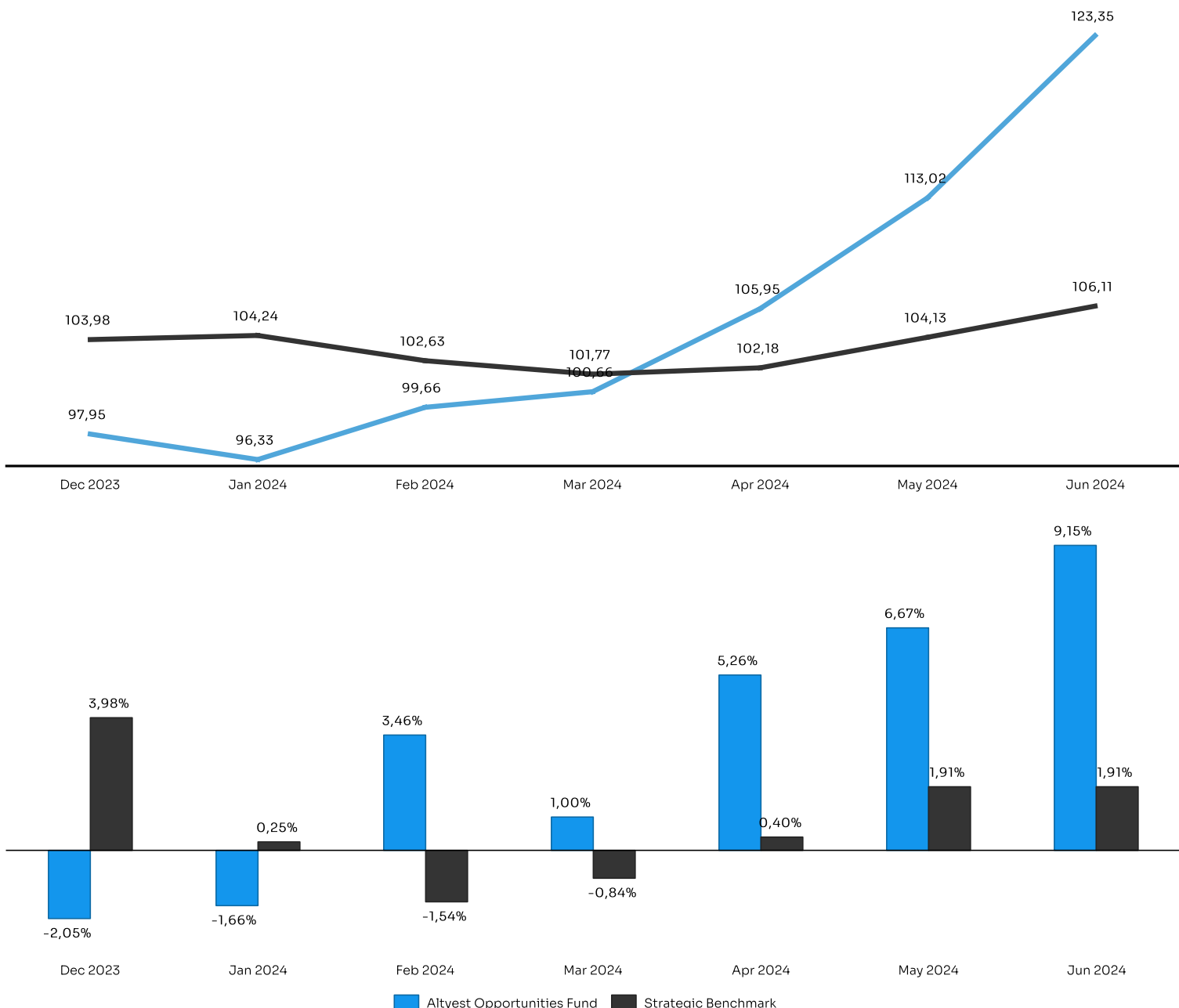
